By using Mr. Keeling's total wages earned during his employment at PGDP (per CES Exhibit 1- subcontractor's work sheet and Exhibit 2 – social security detail from 1951 through 1954) that equals \$9,613.34 earned as a PGDP electrician and dividing the total earnings by the \$2.50 /hourly "electrician" pay rate, Mr. Keeling's total hours equal 3,845 total hours or 480.7 work days worked at the PGDP. Since the Paducah "Special Exposure Cohort" (SEC) requires PGDP workers to work a minimum of 250 days, Mrs. Walter T. Keeling more than qualifies for the maximum compensation for her deceased husband for Parts B and E, since Mr. Keeling more than exceeded the minimum requirements of the Energy Employee Occupational Illness Program Act (EEOICPA), and as a result of his exposures in the workplace to

toxic chemicals and transuranics, died as a result of developing one of the EEOICPA "SEC" qualifying cancers.

I again contacted Mr. Flowers on Monday 6-1-09 and he also provided the name of "Brubaker Electrical", a PGDP subcontractor who <a href="https://hat.now.brubaker.com/hat.now">hat not</a> been listed as working at PGDP, until now. Brubaker Electrical Company was most likely a local "lower tier" subcontractor (as will be confirmed through the DOE FOIA request filed on behalf of Paducah subcontractor workers on 6-3-09 (attached) who held a subcontract with other PGDP prime contractors performing work under F. H. McGraw's primary contract at the time. Since Rust Engineering and Raytheon Engineering Construction were both listed as contractors working at the AEC Oak Ridge plant and their names are listed on the DOE/ DOL "subcontractor work sheet" and Mr. Keeling worked for Raytheon as indicated by his social security records, Mr. Keeling's employment records clearly indicate he did, in fact, work for the DOE contractors who were paying him to perform his job as an electrician.

The production of PGDP construction reports and company records, including the "Declarations" from Mr. Robert Flowers and Don C. Vander Boegh, will confirm that subcontracting companies were omitted from DOE's list of PGDP companies performing work at the Paducah DOE site since the 1950's. Mr. Vander Boegh was the "Chief of the McGraw Guard" force/ FBI clearance investigator who also recalled "Brubaker's" PGDP site presence in the early 1950's.

In addition, I assume you were unaware that the DOE provided construction oversight for the PGDP project through the DOE Oak Ridge, Tennessee facility where Paducah employment and exposure records are currently in existence. These Paducah worker records maintained at the Oak Ridge, Tennessee facility will confirm that many subcontractors and their employees who were, in fact, performing work at the PGDP. With the public disclosure and release of these "subset of contractors records", claimants will finally be able to confirm their employment status at these DOE facilities.

### "DOE FOIA Excerpt 6-03-09"

"Please provide a list of DOE contracts (including subsets of records) that were performed by Rust Engineering and Raytheon Engineering and Constructors on behalf of DOE that were managed by DOE Oak Ridge program officials for the Paducah Gaseous Diffusion Plant site. Include the names, of all subcontractor workers that may have received training at the PGDP. Please redact the first 5 social security numbers and include training records, documents, and construction records maintained for subcontractors working for the above mentioned DOE contractors."

I have attached the "Declaration" statements for witnesses Robert Flowers and Don C. Vander Boegh. In addition, all updated information will be posted on the Commonwealth Environmental Services (CES) web site at <a href="https://www.commonwealthenvironmentalservices.com">www.commonwealthenvironmentalservices.com</a> for your further review and consideration. With the "Disclosure" evidence and that already provided to the DOL, along with the newly discovered confirmation that Rust Engineering

and Raytheon Engineerng and Construction held DOE contracts at the PGDP and Oak Ridge Facility (to be confirmed by through the DOE Oak Ridge contract management), please let me know if you require any additional evidence prior to approving Mrs. Walter T. Keeling's Part B and E claims for compensation.
