Commonwealth Environmental Services, LLC is pleased to announce the adoption of the attached resolution "unanimous" passed by the McCracken County fiscal court on September 10, 2012. Judge Executive Van Newberry was instrumental in clearing the way for a potential "Request for a Congressional Investigation" into the abuses of PGDP workers claims. Judge Newberry stated after the resolution was passed, "If enough workers have to make that move that our Congressional delegation will recognize that and that a Congressional Investigation will take place." "and that there is something going on here!"

Attached below are three (of several) CES claimants who have requested your assistance. Please note that your Congressional staff has "deleted without reading" the claimant's communications to you without reading. If the McCracken County Fiscal Court members pass a resolution requesting your staff to review claims that have been inappropriately denied, can you explain who in your Congressional office is reviewing these claims on behalf of the claimant, or is your Congressional staff continuing to **only** communicate with the DOL representatives and continuing the cycle of ignoring compliant EEOICPA claims? Should those EEOICPA claimants that have provided you and Senator McConnell with detailed evidence of DOL illegal claims denials, expect any "compliance reviews from your staff" or are you allowing DOL to duplicate the illegal denials for a second time? In other words, since it is very obvious claimants are not being treated equally after working and becoming ill at the PGDP, is your staff actually performing a QA/QC of DOL's claims denials and if not, who is ultimately responsible for failing your Kentucky nuclear workers/ constituents? **Why is your staff deleting claimants emails requests for assistance?**
